TO ALL WHOM THESE PRESENTS MAY CONCERN: Bessie Harris Lester

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Four Hundred Seventy & No/100 DOLLARS (\$470.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Eastern side of Burns Street in the City of Greenville, being shown as lot No. 2 on plat of property of Jim Howard made by P. B. Wilson, Jr., December 31, 1945 (being a subdivision of lot No. 10 of the property of R. J. Williams made by R. E. Dalton in November, 1924, recorded in Plat Book "F" at Page 263) and described as follows:

BEGINNING at a stake on the Eastern side of Burns Street 46.1 feet North from Woodfin Avenue at corner of lot No. 1, and running thence with the line of said lot, N. 85-35 E. 103.2 feet to a stake; thence N. 3-46 W. 47.7 feet to a stake at corner of lot No. 3; thence with the line of said lot, S. 89-55 W. 110.4 feet to a stake on Burns Street; thence with the Eastern side of Burns Street, S. 12-31 E. 46.8 feet to the beginning corner; being the same property conveyed to the mortgagor by James A. Howard by deed to be recorded herewith.
