WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, on the Southern side of Circle Road in the Town of Travelers Rest, being shown as lot No. 65 on plat of Love Estates, made by W. J. Riddle in April 1938, recorded in Plat Book "I" at Pages 111 and 112, and described as follows:

BEGINNING at a stake on the Southern side of Circle Road, 640.6 feet West from Tubbs Mountain Road at corner of lot No. 66, and running thence with the line of said lot, S. 36-21 E. 200 feet to stake, corner of lot No. 40; thence with the line of said lot, S. 53-39 W. 100 feet to stake at corner of lot No. 64; thence with the line of said lot, N. 36-21 W. 200 feet to stake on Circle Road; thence with the Southern side of said Circle Road, N. 53-39 E. 100 feet to the beginning corner; being the same property conveyed to the mortgagor by Troy Styles by deed to be recorded herewith.
