TO ALL WHOM THESE PRESENTS MAY CONCERN: I , A. M. Bridges

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twelve Hundred Fifty and No/100 -----  
DOLLARS (\$ 1,250.00 -----), with interest thereon from date at the rate of six (6%) ----- per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Paris Mountain Township, containing 3.56 acres, more or less, and having according to a survey made by R. E. Dalton in September, 1945, the following metes and bounds, to-wit:

"BEGINNING at a point in Poor House Road at corner of property conveyed by R. O. Hudson to Mary Bridges Mauldin by deed recorded in Volume 276 at Page 377; thence along line of said property S. 76-30 E. 401.7 feet to a stake on Poor House Branch; thence up Poor House Branch with the meanders of same, N. 17-0 E. 302 feet to a stake; thence still with branch, N. 3-03 E. 491 feet to a point on Poor House Road; thence along said Road, S. 0-15 E. 41 feet to a stake; thence N. 78-40 to the beginning corner; said premises being a portion of 8.59 -acre tract devised to R. O. Hudson under the Will of E. Bruce Lipscomb, and being the same conveyed to the mortgagor by deed of R. O. Hudson dated October 17, 1945, recorded in Book of Deeds 281 at Page 413."
