MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, William E. Russell, Jr.,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Four Thousand Two Hundred Fifty and No/100 - - - - - DOLLARS (\$ 4,250.00), with interest thereon from date at the rate of four(4%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the Western side of Vannoy Street, in the City of Greenville, being the Northern portion of Lot No. 8 of the Cleveland Land, and described as follows:

"BEGINNING at a stake on the Western side of Vannoy Street 435.2 feet Northeast of Park Avenue, and running thence with the Western side of Vannoy Street, N. 33-29 E. 55 feet to a stake at corner of the Lot conveyed by Charles Lee to L. C.
