TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, William B. Yeargin, of Greenville County, S. C., SEND GREETINGS:

WHEREAS I the said William B. Yeargin

in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to
FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of THREE THOUSAND, SEVEN HUNDRED
AND NO/100 - - - - - four and one-half (4 1/2%)
(\$ 3,700.00) Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of TWENTY-EIGHT AND NO/100
- - - - - (\$ 28.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, will be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I the said William B. Yeargin

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

Office for Greenville County in Plat Book G, at pages 152 and 155, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southwest side of Crain avenue at the corner of Lot No. 106 and running thence along the line of said Crain Avenue, S. 18-08 E. 100 feet to an iron pin at the corner of Lot No. 109; thence along the line of that lot, S. 52-30 W. 285 feet, more or less to an iron pin at the rear corner of Lot No. 108; thence N. 28-30 W. 95.4 feet to an iron pin at the rear corner of Lot No. 106; thence along the line of Lot No. 106, N. 52-30 E. 308.8 feet, more or less, to the beginning corner on the southwest side of Crain avenue.
