MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Billy Capps

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eight Hundred and No/100 DOLLARS (\$800.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, situate on the Northern side of Hall Road, near the Paris Mountain Road, having the following metes and bounds:

"BEGINNING at an iron pin at the Southwest corner of the Lot conveyed to F. A. Capps by Martha R. Bryant, and running thence N. 52 E. 90.42 feet to a stake at the Northwest corner of said property; thence S. 59-3/4 E. 75 feet to iron pin; thence S. 59-3/4 E. 75 feet to stake; thence S. 52 W. 90.42 feet, more or less, to stake on Hall Road; thence with the Northern side of said Lot, 59-3/4 W. 75 feet to the point of beginning."

Said lot being the Western portion of the lot conveyed to F. A. Capps by deed recorded in Book of Deeds 229 at Page 131, and being now shown as Lot No. 8-A of Section 1 on Page P-39 of the County Block Book, and being the identical lot conveyed to the mortgagor by F.
