MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Talmadge Howard  
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Thirty-Two Hundred Fifty & No/100 DOLLARS (\$ 3,250.00), with interest thereon from date at the rate of four (4%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being part of tract known as "Hillhouse" tract, a plat of same being recorded in the R.M.C. Office for Said County in Plat Book A at Page 335, said lot being the Southeast half of lot No. 102 as shown on plat last mentioned, and having the following metes and bounds, to-wit:-

"BEGINNING at an iron pin on New Riverside Road, 100 feet from the Southeastern intersection of the New Riverside Road and McBeth Street ( now called South Franklin Road) and running thence along New Riverside Road, N. 42-30 W. 117 feet, 8 inches to an iron pin; thence S. 47-30 W. 300 feet to an iron pin in rear; thence S. 42-30 E. 117 feet, 8 inches to an iron pin; thence N.47-30 E. 300 feet to an iron pin on New Riverside Road to the beginning corner."
