MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Allie Nelson

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, known and designated as Lot No. 101 on Plat of Norwood Heights, recorded in Plat Book A at Page 133, and being more fully described as follows:

"BEGINNING at an iron pin on the Southeastern side of Main Street, at the joint front corner of Lots Nos. 100 and 101, and running thence in a Southeasterly direction with the line of Lot No. 100, 150 feet to an iron pin on right-of-way of Southern Railway; thence with said right-of-way in a Southwesterly direction, 50 feet to an iron pin, corner of Lot No. 102; thence with the line of said lot in a Northwesterly direction, 150 feet to an iron pin on Main Street; thence with the Southeastern side of Main Street in a Northeasterly direction, 50 feet to the point of beginning"
