MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Eston O. Foster
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Two Thousand & No/100 DOLLARS (\$ 2,000.00), with interest thereon from date at the rate of four (4%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, beginning at an iron pin in a **settlement road**, joint corners with A. H. Sides lands and the Frank Guest land; thence N. 55 W. 5.55 chains along settlement road to an iron pin; thence S. 35 1/2 W. 2.80 chains to an iron pin; thence S. 50 E. 3.52 chains to an iron pin in a settlement road; thence N 68 E. 3.80 chains to the beginning corner, containing one and one-third acres according to a survey made by W. A. Hester November 11, 1941."

Said premises being the same conveyed to the mortgagor by deed of O. A. Foster to be recorded herewith.
