MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Samuel W. Austin, Jr.
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Forty-Eight Hundred & No/100 DOLLARS (\$ 4,800.00), with interest thereon from date at the rate of Four (4%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Franklin Road, in that section known as Sans Souci, about two miles North of the City of Greenville, said lot having the following lines, courses and distances:

"BEGINNING at an iron pin on the Eastern edge of a five-foot side-walk running along Franklin Road, said pin being the joint front corner of the Church lot and Lot No. 1; and running thence along the Southern line of the Church lot, N. 78-13 E. 230.7 feet to an iron pin; thence S. 17-22 E. 75 feet to an iron pin; thence S. 78-13 W. 230.7 feet to an iron pin, on the Southern edge of said side-walk running along the Franklin Road; thence along the Southern edge of said sidewalk N. 17-22 W. 75 feet, to an iron pin, the beginning corner, said lot being known and designated as Lot No. 1 on plat made by W. J. Riddle dated November 1, 1945, Book "B" at Page 63.
