MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: We, W. C. Johnsey and Sue T. Johnsey
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the South side of East North street extension (formerly known as Spartanburg road), just outside the corporate limits of the City of Greenville, and being a portion of lot No. 14 as shown on plat made by W. D. Neeves, Engineer, recorded in the RMC Office in Plat Book "E", at pages 251 and 252, and having the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the South side of East North street extension, joint corner of lots 14 and 15 and running thence with the line of lot 15 S. 48-32 E. 194 feet to iron pin in line of a 10 foot alley; thence with the North side of said alley S. 41-04 W. 67 feet and 6 inches; thence N. 48-32 W. 196 feet to a pin on North Street extension; thence with the South side of East North Street extension N. 41-28 E. 67 feet 6 inches to the point of beginning. Said premises being the same conveyed to the mortgagors by S. S. Newell by deed to be recorded herewith.
