computed and paid quarterly (and principal) on the 8th day of July, October, Janu-

past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder thereof, who may sue thereon and fore-
close this mortgage; and in case said note, after its maturity should be placed in the hands of an attorney for suit or collection, or if before its maturity, it should
be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note or this mortgage in the hands of an
attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10%
per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All those certain pieces parcels or lots of land with the buildings and improvements
thereon situate, lying and being on the West side of South Main Street, in the City of Greenville
County of Greenville, State of South Carolina, being known as Lots 7 and 8 on plat made by F. G.
Rogers, Engineer, recorded in Plat Book C at page 49 and having, according to said plat, the
following metes and bounds, to-wit:-

BEGINNING at a point on the West side of South Main Street, in the center of a brick wall,
joint corner of Lots 6 and 7, and running thence along the center of said brick wall N. 58-05 W.
33 feet, 5 inches to a point in the West edge of a brick wall; thence along the Western edge of
said brick wall N. 35-55 E. 40 feet, 9 inches, more or less, to the Northwest corner of the brick
building situate on said lots; thence along the Northern or outer edge of said brick wall, S. 58-05
E. 31 feet, 5 inches to a point in the Western side of South Main Street; thence along the West-
ern side of South Main Street, S. 31-55 W. 40 feet, 9 inches to the point of beginning.
