**Greenville, South Carolina** - - - - - hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto **Liberty Life Insurance Company**, a corporation organized and existing under the laws of **South Carolina**, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of **Forty-two Hundred & No/100ths** - - - - - Dollars (\$ **4200.00**), with interest from date at the rate of **Four & One-Half** per centum ( **4 1/2** %) per annum until paid, said principal and interest being payable at the office of **Liberty Life Insurance Company** in **Greenville, South Carolina** or at such other place as the holder of the note may designate in writing, in monthly installments of **Twenty-six & 59/100ths** Dollars (\$ **26.59**), commencing on the first day of **July**, 19**46**, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of **June**, 19**66**.

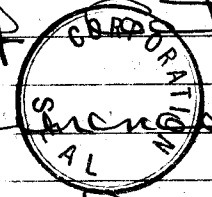
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **Greenville**, State of South Carolina:

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the East side of McAdoo Avenue, near the City of Greenville, in the County of Greenville, State of South Carolina, being shown as Lot #63 on Plat of Glenn Grove Park, made by R. E. Dalton, Engineer, May, 1924, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "F", Page 233 and having according to said Plat and a recent survey made by R. E. Dalton, Engineer, May 16, 1946, the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the East side of McAdoo Avenue at joint front corner of Lots 62 and 63, said pin also being 270.1 feet South from the Southeast corner of the intersection of McAdoo Avenue and Laurens Road and running thence with the line of Lot 62 S. 74-12 E. 150 feet to an iron pin; thence with the rear line of Lot 54, S. 15-48 W. 50 feet to an iron pin; thence with the line of Lot 64, N. 74-12 W. 150 feet to an iron pin on the East side of McAdoo Avenue; thence with the East side of McAdoo Avenue, N. 15-48 E. 50 feet to the beginning corner.
