I, Thomas P. Parks, of Greenville, S. C.

SEND GREETINGS:

WHEREAS I, the said Thomas P. Parks

in and by my certain promissory note, in writing, of even date with these presents, well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of THREE THOUSAND AND NO/100 - -

four and one-half (4 1/2%) (\$3,000.00) Dollars, with interest at the rate of 5 1/2 (5 1/2%) per centum per annum, to be repaid in instalments of TWENTY-FIVE AND NO/100

(\$ 25.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I, the said Thomas P. Parks

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do, grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., the following described property to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the West side of Jedwood Drive, being known and designated as Lot No. 147 and

the Southern half of Lot No. 146 as shown on plat No. 3 of the property of Overbrook Land Company made by R. E. Dalton, Engineer, January 1924, recorded in the R.M.C. Office for Greenville County, in Plat Book F, page 218, and having the following metes and bounds, according to said plat, to-wit:-

"BEGINNING at an iron pin on the West side of Jedwood Drive joint corner of Lots No. 135 and 147 and running thence with the West side of Jedwood Drive N. 6-28 W. 96.9 feet to an iron pin in center of Lot No. 146; thence through the center of said lot, S. 83-32 W. 123.8 feet to an iron pin in the rear line of Lot No. 139; thence with the rear line of Lots No. 139, 138 and 137, S. 39-28 E. 41.3 feet to an iron pin in rear line of Lot No. 137; thence with the rear line of Lots No. 137 and 136, S. 58-28 E. 80 feet to an iron pin joint rear corner of Lots No. 135 and 136; thence with the rear line of Lot No. 135, S. 77-56 E. 40 feet to the beginning corner." This being the same lot conveyed to me by Athalie P. Moseley by deed dated March 1, 1946 and recorded in the R.M.C. Office for Greenville County in Vol. 288, page 111.
