All that piece or lot of land in Fairview Township, Greenville County, State of South Carolina located on the W/S of the C & W.C. Railroad just south of the Town of Simpsonville, adjoining lands of Mrs. Osa B. Abercrombie, Pierce J. Mayfield, and Mrs. B. H. Richardson, and more particularly described as follows:-

BEGINNING at an iron pin in center of the C & W. C. Railway Track - P.J. Mayfield corner and running along his line S 88 W 313.5 ft. to iron pin, Mrs. B. H. Richardson lands; thence along her line N 5 1/2 E 189 ft. to iron pin, Mrs. Abercrombie's lot; thence along her line S 81 1/4 E 101.3 ft. to iron pin; thence N 2 E 19 ft. to iron pin; thence further along the Abercrombie line S 89 1/2 213 ft. to a point in center of C & W.C. Railway Track; thence along center of track S 6 1/2 W. 169 ft. to the beginning corner as shown on a chart of survey made by E. E. Gary, Surveyor, on March 22, 1946 and being the same property conveyed to me by Mrs. Bessie H. Richardson by deed dated April 22, 1946 and recorded in the RMC Office for Greenville County, S. C. Vol. 290 page 222.
