with interest thereon from June 11, 1946 at the rate of 8 per centum per annum, to be computed and paid annually

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be mortgaged by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, including buildings and improvements, lying and being situate on the Southeast side of High Hill Street, being known and designated as Lot #64, Augusta Road Hills, near the City of Greenville, County of Greenville, State of South Carolina, according to plat of said Augusta Road Hills prepared by Dalton and Neves, Engineers, December 1940 including revisions made in June and October 1941 as recorded in the R.M.C. Office, County of Greenville, South Carolina in Plat Book "M" on page 33, having the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the Southeast side of High Hill Street at joint front corner of Lots #63 and #64; thence S. 47-50 E. 165 feet to an iron pin at joint rear corner of Lots #63 and #64; thence N. 42-10 E. 60 feet to an iron pin at joint rear corner of Lots #64 and #65; thence N. 47-50 W. 165 feet to an iron pin on the Southeast side of High Hill Street at joint front corner of Lots #64 and #65; thence S. 42-10 W. 60 feet to an iron pin on the Southeast side of said Street at joint front corner of Lots #63 and #64, the point of beginning.
