MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Harold E. McKinney

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Thirty-Five Hundred and No/100 - - - - -
DOLLARS (\$ 3,500.00), with interest thereon from date at the rate of four (4%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northeastern side of Carolina Avenue, near the City of Greenville, being known and designated as Lot No. 10 of Block B, on plat of East Highlands Estates, made by Dalton and Neves, Engineers, April 1940, recorded in the R.M.C. Office for Greenville County in Plat Book K at Pages 35 and 36, and having according to said plat, the following metes and bounds, to-wit :-

"BEGINNING at an iron pin on the Northeastern side of Carolina Avenue at joint corner of Lots Nos. 9 and 10 of Block B, and running thence with the line of Lot No. 9, N. 79-25 E. 173.5 feet to an iron pin on the Southwestern side of a 5 foot strip reserved for utilities; thence along the Southwestern side of said strip reserved for utilities, S. 32-23 E. 60 feet to an iron pin; thence with the line of Lot No. 11, S. 71-13 W. 167.2 feet to an iron pin on the Northeastern side of Carolina Avenue; thence with the Northeastern side of Carolina Avenue, N. 31-33 W. 85 feet to the beginning corner."

Said premises being the same conveyed to the mortgagor by E. W. Fore by deed recorded in Volume 286 at Page 357.
