TO ALL WHOM THESE PRESENTS MAY CONCERN:----- I , W. A. Timms

----- (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of-----

Twenty-Seven Hundred Fifty and No/100

DOLLARS (\$ 2,750.00 -----), with interest thereon from date at the rate of six (6%) ----- per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, near the City of Greenville, and having, according to survey dated June, 1946 by Dalton and Neves, Engineers, the following metes and bounds, to-wit:-

"BEGINNING at an iron pin on the Northern side of Hall Road, joint corner of Property now owned by Mrs. M. A. Bryant and Lee Hall, and running thence N. 52 E. 206.42 feet to an iron pin; thence N. 60-55 E. 101 feet to an iron pin; thence S. 49 W. 190 feet to an iron pin on the Northern side of Hall Road; thence with said Road, S. 60-15 E. 30 feet to a stake; thence continue with said Road, S. 48 E. 59 feet to the point of beginning."
