MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: James A Gambrell

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Sixty-Five Hundred and No/100 DOLLARS (\$ 6500.00), with interest thereon from date at the rate of five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Southern side of East North Street in the City of Greenville, and having the following metes and bounds, to-wit:-

"BEGINNING at an iron pin on the Southeastern side of East North Street, said pin being 98 feet and 4 inches from the Southeastern corner of North Street and Carolina Avenue, and running thence S. 15 E. 126 feet and 1/4 inch to an iron pin on a 10-foot alley; thence N. 76-45 E. 49 feet and 2 inches to the corner of Lots Nos. 2 and 3 of the old survey of Boyce Addition, Block 11; thence N. 15 W. 126 feet and 1/4 inch to an iron pin on East North Street; thence with the Southeastern side of East North Street, S. 76-45 W. 49 feet and 2 inches to the beginning corner."
