"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, in Ward 6 of the City of Greenville, and known and designated as Lot No. 11, Block F, according to plat of property of Chapin Springs Land Company, recorded in Plat Book E, Page 41, in the RMC Office for Greenville County, and being more particularly described as follows:

"BEGINNING at a stake on the Northern side of Rose Avenue, joint front corner of Lots Nos. 11 and 12; thence with the line of said lots, N. 2-0 W. 150 feet to a stake; thence with the rear line of Lots Nos. 9 and 10, N. 88-0 E. 84.7 feet to a stake; thence with the line of property now or formerly of McDaniel, S. 10-44 W. 153.9 feet to a stake; thence with the Northern side of said Avenue, S. 88-0 W. 51.2 feet to the beginning."
