To All Whom These Presents May Concern:

I, Robert Spence - - - - - SEND GREETING:

WHEREAS, I the said Robert Spence

in and by my certain promissory note in writing of even date with these Presents, am well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of **Seventeen Hundred - - - - - (\$ 1700.00)** Dollars, with interest from the date hereof at the rate of **seven** per cent (**7 %**) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of **Twenty-seven and 20/100 - - - - - (\$ 27.20)** dollars
