"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Western side of Parkwood Drive, near the City of

Greenville, being shown as Plat No. 131 on plat of Hillcrest Section of North Hills, recorded in Plat Book H at Page 136 and described as follows:

"BEGINNING at a stake on the Western side of Parkwood Drive 248 feet South from Hillcrest Drive at corner of Lot No. 130 and running thence with the line of said lot, N. 71-00 W. 140 feet to a stake at corner of Lot No. 122; thence with the line of said lot, S. 18-30 W. 70 feet to a stake at corner of Lot No. 132; thence with the line of said lot, S. 71-00 E. 140 feet to a stake on Parkwood Drive; thence with the Western side of Parkwood Drive, N. 18-30 E. 70 feet to the beginning corner."
