MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, James H. Robinson

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Saluda Township, on the Tugaloo Road, adjoining property of Barney E. Dewease, near Marietta, S. C., containing 2 1/2 acres, and being more particularly described by metes and bounds, as follows:

"BEGINNING at an iron pin on the Tugaloo Road, corner of property of Barney E. Dewease, and running thence with the line of said property, S. 64 E. 1.85 chains to an iron pin; thence S. 3 1/2 E. 4.85 chains to an iron pin in line of property of Slater Manufacturing Company; thence with the line of said property, N. 68 E. 4.33 chains to an iron pin; thence N. 29 W. 6.30 chains to iron pin; thence N. 81 W. 2.52 chains to an iron pin in Tugaloo Road; thence with the Tugaloo Road S. 20 W. 2.00 chains to the beginning corner."
