WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of-----
Twenty-one Hundred and No/100 -----

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Cleveland Township, on the North side of Geer Highway near Marietta, South Carolina, containing approximately 3 acres, more or less, and according to survey made by W. A. Hester, Surveyor on April 5th 1946, is described as follows:

BEGINNING at an iron pin on the South side of Slaughter Pen Road, corner of property of J. A. McC Carson and running thence with the Southern side of said road as follows: S. 79 E. 3.25 chs.; S. 53 E. 51 links; S. 16 E. 90 links; S. 7-30 E. 3.40 chs. and S. 18 W. 3 chs. to stake at Northwest corner of the intersection of Slaughter Pen Road with Geer Highway, thence with Geer Highway as follows: N. 43 W. 2 chs.; N. 50 W. 1.88 chs. and N. 58 W. 1.96 chs. to stake on Highway at corner of property of J. A. McC Carson, thence with his line N. 15 E. 4.33 chs. to beginning corner.
