BEGINNING at an iron pin on the North side of Morgan Street said pin being 150 feet West from the Northwest corner of the intersection of Morgan Street and Parker Avenue, joint corner of Lots Nos. 5 and 6 and running thence with the line of Lot No. 5 N. 12-45 W. 168 feet to an iron pin; thence S. 81-30 W. 45 feet to an iron pin; thence S. 10-00 E. 168 feet to an iron pin on the North side of Morgan Street; thence with North side of said street N. 81-30 E. 50 feet to the beginning.
