annually

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including ~~of~~ \$50.00 of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

BEGINNING at an iron pin on said Street two hundred feet from the West side of the proposed extension of Bailey Street and running with Oscar Street N. 54-15 W. 50 feet to an iron pin at corner of Lot #6; thence with line of Lot #6 S. 30 W. 125 feet to an iron pin; thence with line of Lot #13 S. 54-15 E. 50 feet to an iron pin; thence N. 30 E. with line of Lot #4, 125 feet to the beginning corner, and being the same lot inherited by Zadie Jackson Moss from Roxie Harner, she being the sole heirs of Roxie Harper, deceased.
