MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Harold J. Wood,
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Three Thousand and No/100 DOLLARS (\$3,000.00), with interest thereon from date at the rate of four (4%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the east side of Ninth Avenue in Judson Mill Village No. 2, and being known and designated as Lot No. 4 of Block "F" on plat of said Judson Mill Village No. 2, made by Dalton and Neves, Engineers, in March 1939, and recorded in the R.M.C. Office for Greenville County in Plat Book "K" at Pages 1 and 2, and having the following metes and bounds, to-wit: BEGINNING at an iron pin on the east side of Ninth Avenue at the corner of Lot No. 3 of Block F, which point is 148.2 from the southeast corner of the intersection of Ninth Avenue and an unnamed Street, and running thence along the line of Lot No. 3, N. 80-46 E. 127 ft. to an iron pin thence S. 8-43 E. 50 ft. to an iron pin at the rear corner of Lot No. 5; thence along the line of said lot No. 5, S. 80-46 W. 126.5 ft. to an iron pin on the east side of Ninth Avenue; thence along the line of said Ninth Avenue, N. 9-14 W. 50 ft. to the beginning corner; being the same premises conveyed to the mortgagor by Harold H. Garrison and Louise H. Garrison by deed to be recorded herewith."
