MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Paul H. Graham

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Seven Thousand and No/100

DOLLARS (\$ 7,000.00), with interest thereon from date at the rate of four (4%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, near the City of Greenville, and being known and designated as Lot No. 20 on Cammer Avenue as shown on plat of property of G. F. Cammer recorded in Office of R. M. C. for Greenville County, in Plat Book "L" at page 115, and being more particularly described as follows:

BEGINNING at a point on Cammer Avenue, joint front corners of lots 19 and 20 and running N. 36-24 W. 178 feet to a point, joint rear corners of lots 19 and 20; thence S. 44-17 W. 76.85 feet to a point at corner of lots 20 and 21; thence S. 36-24 E. 178 feet to a point, joint front corners of lots 20 and 21; thence N. 44-17 E. 76.85 feet to the point of beginning.

Being the same premises conveyed to the mortgagor here in by Mary Lou Cammer by deed dated 24th of October, 1946, recorded in Volume 301, at page 147.
