MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:----- I, Carlos R. Henderson  
----- (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of-----  
Fifty-Five Hundred and No/100 -----  
DOLLARS (\$ 5,500.00-----), with interest thereon from date at the rate of four (4%)----- per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being Lot No. 102 fronting on Lownes Hill Road, according to Plat No. 3, property of Overbrook Land Company and Woodville Investment Company, made by R. E. Dalton, Engineer, in January 1924, and recorded in the R.M.C. Office for Greenville County in Plat Book "F" at Page 218, and being more particularly described as follows:

"BEGINNING at an iron pipe on the north side of Lownes Hill Road, joint front corner of Lots Nos. 101 and 102, and running thence along Lownes Hill Road, N. 76-44 W. 80 feet to an iron pipe; thence N. 10-39 E. 133 feet to an iron pipe; thence S. 8-16 E. 75 feet to an iron pipe; thence S. 8-06 W. 149.4 feet to the beginning corner.

Said premises being the same conveyed to Carlos R. Henderson and Doris A. Henderson by G.C. Gibson by deed dated October 14, 1936, recorded in Volume 301 at Page 186; the one-half interest of Doris A. Henderson being conveyed to Carlos R. Henderson by deed to be recorded herewith.
