MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Merle H. Edwards

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the North side of North Franklin Road, known and designated as the front portion of Lot No. 307 on plat of Colonia Company, recorded in Plat Book "J" at page 190, and having, according to said plat, the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the North side of Franklin Road at the joint front corner of lots 306 and 307 and running thence with the North side of Franklin Road, S. 55-16 E. 100 feet to the corner of lot 308; thence with the line of Lot 308, N. 39-44 E. 200 feet; thence with other property of the mortgagor, N. 55-16 W. 100 feet to iron pin, in line of lot 306; thence with the line of lot 306, S. 32-34 W. 200 feet to the point of beginning.
