"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, in School District 12B, and containing 1-3/4 acres, more or less adjoining lands now or formerly owned by William B. Langford and Mrs. E. M. Cleveland and being a part of the real estate of William Duckworth, deceased, and being more particularly described as follows:

"BEGINNING at a point on the Jones Gap Road, 8 feet South of the land now or formerly owned by Langford, leaving a space for road; thence parallel with Langford's line, 140 yards to a stake 3x; thence S. 40 yards to a stake 3x; thence East 140 yards to a stake 3x on the G. & K. R. ilroad right-of-way; thence N. 40 yards to the beginning corner."
