"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Grove Township, on Highway No. 29, near Grove Station, and being known and designated as Lot No. 7 of the division of lands of Mrs. E. A. Cason, and having the following metes and bounds, according to Plat made by W. E. Adkins, Surveyor, dated July 27, 1946, to-wit:-
