WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of.....

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, being known and designated as Lot No. 22 on plat of the property of Lucy L. Hindman made by W. J. Riddle, Surveyor, in October 1939, and having, according to said plat, the following metes and bounds, to-wit:-

"BEGINNING at an iron pin on the Southern side of Parkins Mill Road( formerly unnamed), joint Northern corner of Tracts Nos. 21 and 22, and running thence with the Southern side of said Road, N. 69-55 E. 364 feet to an iron pin in said Road; thence S. 32-30 W. 422 feet to an iron pin; corner of Lot No. 22; thence with the line of Lot No. 22, N. 37-30 W. 254 feet to the beginning corner, containing 1.11 acres."
