Whereas, we the said Ansel A. Dacus and Annie L. Dacus

in and by our certain promissory note in writing, of even date with these presents, are well and truly indebted to Louise C. Gower

in the full and just sum of Three Hundred Fifty One & 39/100ths (\$351.39) Dollars

in the full and just sum of Three Hundred Fifty One & 39/100ths (\$351.39) Dollars, to be paid as follows:  
The sum of \$25.00 on the principal on the 21st day of February 1947 and the sum of \$25.00 on the 21st day of each month of each year thereafter until the said principal indebtedness is paid in full

with interest thereon from this date at the rate of six (6%) per centum per annum, to be computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at same rate as principal and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the North side of the Old Spartanburg Road, near the City of Greenville, in the County of Greenville, State of South Carolina, being shown as Lot #3 on Plat of property of W. E. McCain, made by C. M. Furman, Jr., Engineer, November 1927, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "H", Page 74, and having, according to said Plat, the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the North side of the Old Spartanburg Road at joint front corner of Lots 2 and 3, and running thence with the line of Lot 2, N. 23-58 E. 150 feet to an iron pin; thence S. 66-02 E. 42 feet to an iron pin; thence with the line of Lot 4, S. 23-58 W. 150 feet to an iron pin on the North side of the Old Spartanburg Road; thence with the North side of said Road, N. 66-02 W. 42 feet to the beginning corner.
