"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the South side of Tindall Avenue, in the City of Greenville and being known and designated as lot No. 42 of Block B., as shown on plat of ^{Park} Cagle subdivision, recorded in the R.M.C. office for Greenville County in plat book C. at page 238, and having according to said plat the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the South side of Tindall Avenue, at joint front corner of lots No. 42 and 43, and running thence with the line of lot 43 S. 24-32 E. 160.6 feet to an iron pin in line of lot No. 6; thence with the line of lots 6 and 7 N. 73-01 E. 50 feet to iron pin, corner of lot No. 41; thence with the line of lot No. 41 N. 20-36 W. 160.5 feet to iron pin on Tindall Avenue; thence with the South side of Tindall Avenue S. 72-05 W. 61 feet to the point of beginning.
