TO ALL WHOM THESE PRESENTS MAY CONCERN: We, C. Frank Pittman, Jr. and Mildred L. Pittman

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of-----

Thirty-Five Hundred and No/100 -----

DOLLARS (\$ 3500.00 -----), with interest thereon from date at the rate of five & one-half ----- per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, near Travelers Rest, and being known and designated as Lot No. 58 as shown on plat of the Love Estate, recorded in the R.M.C. Office for Greenville County in Plat Book "K" at Page 31, and having, according to said plat, the following metes and bounds, to-wit:-

"BEGINNING at an iron pin on the South side of Love Drive, at the joint front corner of Lots Nos. 58 and 59, and running thence along the South side of Love Drive, S. 64 W. 100 feet to an iron pin, joint corner of Lots Nos. 57 and 58; thence with the line of Lot No. 57, S. 25-41 E. 200 feet to an iron pin; thence with the line of Lot No. 33, N. 64 E. 100 feet to the joint rear corner of Lots Nos. 58 and 59; thence with the line of Lot No. 59, N. 25-41 W. 200 feet to the point of beginning."
