MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, O. E. Ridgeway  
..... (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Eastern side of Hawthorne Lane (formerly Ligon Street), being shown as all of Lot No. 86, the Northern one-half of Lot No. 85 and the Southern one-half of Lot No. 87, and when described as a whole, have the following metes and bounds, to-wit:-

"BEGINNING at an iron pin on the Eastern side of Hawthorne Lane, which pin is in the center of the front line of Lot No. 85, and running thence with the Eastern side of Hawthorne Lane, N. 39-25 E. 100 feet to an iron pin in the center of the front line of Lot No. 87; thence in a straight line through the center of Lot No. 87, N. 49-12E. 311.7 feet to an iron pin on Brushy Creek; thence S. 25-48 E. 103.4 feet to an iron pin in the center of the rear line of Lot No. 85; thence S. 49-12 W. 286 feet, more or less, to an iron pin on Hawthorne Lane, the point of beginning".
