MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, A. D. Howland, and Kathleen H. Howland,

----- (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of -----

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Township, about six miles from the City of Greenville, and about one mile North of the Town of Mauldin, located just West of the Greenville-Laurens Highway, known as Tract No. 1 of the property of Dorothy Daves Howard as shown on a Plat of said property made by W. J. Riddle, Surveyor, January 1947, and recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book Q at Page 113, and containing 2.12 acres, more or less, and having, according to said Plat, the following metes and bounds, to-wit:-
