WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Nine Thousand and No/100 DOLLARS (\$9,000.00), with interest thereon from date at the rate of five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, particularly described as follows: 19 of Goddard-McPherson property, and being more

"BEGINNING at an iron pin on McPherson Lane, a point on the Northeast corner of property of Mrs. R. L. Rabb, and running along McPherson Lane, N. 48-47 E. 95 feet to an iron pin on McPherson Lane; thence S. 41-13 E. 226 feet to an iron pin on rear line of Goddard-McPherson Subdivision; thence S. 55-55 W. 66.7 feet to an iron pin on Southeast corner of lot of Mrs. R. L. Rabb; thence N. 48-45 W. 219.6 feet along property of Mrs. R. L. Rabb to the beginning point on McPherson Lane; being the same property conveyed to the mortgagor by Cora H.
