To All Whom These Presents May Concern:

We, W. R. Lunny and Freddie M. Lunny SEND GREETING:

WHEREAS, we the said W. R. Lunny and Freddie M. Lunny in and by our certain promissory note in writing of even date with these Presents, are well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of Seven Hundred - - - - - (\$ 700.00) Dollars, with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of Eleven and 20/100 - - - - - (\$ 11.20) dollars
