I, Lyndon W. Manheim, Jr. of Greenville County SEND GREETINGS:

WHEREAS I, the said Lyndon W. Manheim, Jr.

in and by my _____ certain promissory note, in writing, of even date with these presents am _____ well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of FIVE THOUSAND, FIVE HUNDRED AND NO/100 - - - - -

(\$5,500.00) Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of FORTY-SIX AND NO/100 - -

_____ (\$46.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, on the west side of McDonald street, and being known and designated as the major portion of Lot No. 90 of a subdivision known as "North Hills" as shown on plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book H, at page 138, and having the following metes and bounds, to-wit:-

"BEGINNING at an iron pin on the west side of McDonald street at the northwest corner of the intersection of a 10-foot alley, which point is 180 feet north of Gallivan avenue, and running thence along the north side of said alley (as widened), N. 70 W. 161 feet to an iron pin at a point 5 feet north of the original rear corner of Lot No. 90; thence N. 19-15 E. 65 feet to an iron pin at the rear corner of Lot No. 91; thence along the line of said Lot No. 91, S. 71-43 E. 163.3 feet to an iron pin at the corner of said lot on McDonald street; thence along the west side of of said McDonald street, S. 19-17 W. 70 feet to the beginning corner. Being the same lot conveyed to me by Allen E. Vaughn by deed of even date not yet recorded.
