TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Harold J. Sheils

----- (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of -----
Forty-Six Hundred and No/100 - - - - -

DOLLARS (\$ 4600.00 -----), with interest thereon from date at the rate of Five (5%) ----- per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Eastern side of Tomassee Avenue, near the City of Greenville, being shown as Lots Nos. 58 and 59 on plat of Augusta Circle made by R. E. Dalton in November 1921, recorded in the R.M.C. Office for Greenville County in Plat Book "F" at Page 23 and described as follows:

"BEGINNING at a stake on the eastern side of Tomassee Avenue 165.6 feet South from West Augusta Drive at corner of Lot No. 57, and running thence with the line of Lots Nos. 57 and 56, S. 71-35 E. 166.36 feet to a stake in line of Lot No. 55; thence with the line of said lot, S. 21-35 W. 100 feet to a stake, corner of Lot No. 60; thence with the line of said lot, N. 71-35 W. 166.36 feet to a stake on Tomassee Avenue; thence with the Eastern side of Tomassee Avenue, N. 21-35 E. 100 feet to the beginning corner."

Said premises being the same conveyed to the mortgagor by two separate deeds - one recorded in Book of Deeds 242 at page 357 and the other by deed recorded in Book of Deeds 242 at page 351.
