NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

Office for Greenville County in Plat Book "H" at Pages 212 and 213, and when described together, have according to said plat the following metes and bounds, to-wit:-

"BEGINNING at an iron pin on a 30-foot road, corner of Tract No. 3, and running thence S. 16 E. 324 feet to an iron pin; thence S. 47-10 E. 138 feet to an iron pin; thence N. 29-51 E. 171.2 feet to an iron pin; thence N. 40-45 E. 97 feet to an iron pin; thence N. 53-43 E. 393 feet to an iron pin; thence N. 40-58 E. 257.6 feet to an iron pin; thence N. 45-24 E. 585 feet to an iron pin, corner of property now or formerly owned by W. G. Peterkin; thence with the line of the Peterkin property N. 53-38 W. 462.3 feet to an iron pin in center of said 30-foot road; thence with the center of said road, S. 32-05 W. 416 feet; thence continuing with said road, S. 35-30 W. 205 feet; thence continuing with said road, S. 37-35 W. 100 feet to an iron pin in bend of said road; thence continuing with said road, S. 67-35 W. 236 feet to an iron pin; thence continuing with said road, S. 46-45 W. 346 feet to the beginning corner."
