"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, about two and one-half miles from the City of Greenville, in Greenville Township, about two and one-half miles from the City of Greenville in subdivision known as Sans Souci and being known and designated as Lot No. 22, according to plat recorded in Plat Book G, Page 160, and having the following metes and bounds:

BEGINNING at a stake on the East side of Gridley Street, joint corner of Lot No. 21 and running thence with the line of Lot No. 21, N. 80-26 E. 136 feet to alley; thence with said alley, S. 22-40 E. 52 feet, more or less, to corner of Lot No. 23; thence with the line of Lot No. 23, S. 80-46 W. 143.9 feet, more or less, to a stake on Gridley Street; thence with Gridley Street, N. 11-19 W. 50 feet to the point of beginning.
