MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Mrs. Johnnie A. Bruce and Mrs. Glenn A. Young

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the Western side of Atwood Street and being more particularly described as follows:

"BEGINNING at an iron pin on the corner of the lot now or formerly owned by Zimmerman on the Western side of Atwood Street, which pin is 458 feet from the intersection of Atwood Street and Buncombe Street, and running thence along the Western side of Atwood Street, N. 48 E. 90 feet to an iron pin; thence N. 40-15 W. 180 feet to a stake; thence S. 56-13 W. 95 feet to a stake; thence S. 40-15 E. 193 feet to the beginning corner."

An undivided one-third interest having been conveyed to the mortgagors herein, who owned the other two-thirds interest, by Margaret A. Gerrald by deed to be recorded herewith.
