KNOW ALL MEN BY THESE PRESENTS, That

Waites T. Edwards - - - - -

of Greenville County and State aforesaid, hereinafter called first party, whether one or more, SEND GREETINGS:

WHEREAS, First party is indebted to the Land Bank Commissioner, acting pursuant to Part 3 of the Emergency Farm Mortgage Act of 1933, as amended, hereinafter called second party, as evidenced by a certain promissory note, of even date herewith, for the principal sum of ~~Three Hundred and No/100~~

(\$ 300.00) Dollars, payable to the order of the second party, together with interest from the date of said note on the principal sum remaining from time to time unpaid, at the rate of Five (5%) per centum per annum, the first payment of interest being due and payable on the first day of November, 194 47, and thereafter interest being due and payable ----- annually; said principal sum being due and payable in Three (3) equal, successive, ----- annual installments of One hundred and No/100 (\$ 100.00) Dollars each, and a final installment of ----- Dollars, the first installment of said principal being due and payable on the first day of November, 194 47, and thereafter the remaining installments of principal being due and payable ----- annually until the entire principal sum and interest are paid in full; all of which and such other terms, conditions, and agreements as are contained in the said note, will more fully appear by reference thereto.

NOW, KNOW ALL MEN, That first party, in consideration of the debt as evidenced by the said note, and for better securing the payment thereof to second party, according to the terms of the said note, and the performance of the conditions and covenants herein contained, and also in consideration of the sum of One Dollar to first party in hand well and truly paid by second party, at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, in fee simple, and by these presents does grant, bargain, sell and release in fee simple, unto second party, his successors and assigns, the following described lands, to wit:

All that piece, parcel and lot of land lying and being in Chick Springs Township, Greenville County, South Carolina, containing fifty and 79/100 (50.79) acres, more or less, being bounded on the north by Mountain Creek and lands of W. S. Edwards, on the east by W. S. Edwards and lands of Rimer, on the south by the Greenville Nursery and on the west by Barton and Black. Said tract of land is more fully outlined and delineated on a plat prepared by J. Mae Richardson, Reg. L.S. dated March 1947, and recorded in R.M.C. Office, Greenville County, in Book ----- Page ----- and reference is thereto made for a more definite and particular description.

This is the same tract of land conveyed to Waites T. Edwards by William S. Edwards by deed dated January 23, 1946, recorded in Book 285, page 392, R.M.C. Office, Greenville County.

First party further covenants and agrees that if at any time it shall appear to second party that first party may be able to obtain a Federal Land Bank Loan on the property described herein, first party shall on request of second party, apply for a Federal Land Bank loan to pay off the indebtedness secured hereby and shall accept such loan as may be offered to him by the Federal Land Bank if sufficient in amount to pay the indebtedness secured hereby and pay for any stock which it may be necessary for first party to purchase in obtaining such loan.

The debt secured by the within mortgage having been paid in full, said mortgage is hereby satisfied and the liability thereof discharged, this the 30th day of November, 1947.

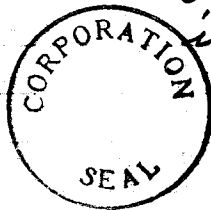
