MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Lillie Harris, William Grant and Louise Harris Grant (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Western side of Y.M.C.A. Street, near the City of Greenville, being shown as Lot No. 2, Block "A", on plat of City View, recorded in the R.M.C. Office for Greenville County in Plat Book "A" at Page 461, and described as follows:

"BEGINNING at a stake on the Western side of Y.M.C.A. Street, 250 feet North from Summitt Street, corner of Lot No. 3, and running thence with the line of said lot, N. 89-30 W. 160 feet to a stake in line of Lot No. 56; thence with the line of said lot, N. 00-30 E. 50 feet to a stake, corner of Lot No. 1; thence with the line of said lot, S. 89-30 E. 160 feet to a stake on Y.M.C.A. Street; thence with the Western side of Y.M.C.A. Street S. 00-30 W. 50 feet to the beginning corner."
