MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Hoyt L. Walters

----- (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Four Thousand and No/100 -----

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, on the Northwestern side of McElhaney Road in the Town of Travelers Rest, and described as follows:

"BEGINNING at a stake on the Northwestern side of McElhaney Road at corner of the Poe property, and running thence with the line of said property, N. 48-00 W. 211.6 feet to a stake, corner of other property of the mortgagor; thence with the line of said property, S. 40-30 W. 105 feet to a stake in line of property of Carl R. Vest; thence with the line of said property, S. 48-00 E. 211.6 feet to a stake on McElhaney Road; thence with the Northwestern side of McElhaney Road, N. 40-30 E. 105 feet to the beginning corner."
