All that piece, parcel or lot of land in Oaklawn Township, Greenville County, State of South Carolina, on the West side of Highway #29, adjoining lands of Henry Elgar Smith on the North Pelzer Mfg. Co. on the West, and T.H. and James Martin on the South, containing 8.76 acres, more or less, as shown by plat made by J. Coke Smith, June 1, 1945 and having according to said plat, the following metes and bounds, to-wit:-

BEGINNING at a point in center of said highway at the Southwest corner of the tract of land conveyed by H. C. Smith to Henry Elgar Smith and running thence along center of said highway S. 23 W. 3.48 chains to a point at corner of lands of T. H. and James Martin; thence along line of said Martin lands S. 85-00 W. 2170 chains to a stone and iron pin in line of lands of Pelzer Mfg. Co.; thence along line of said lands of Pelzer Mfg. Co.
