MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: GOWANSVILLE BAPTIST CHURCH

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of-----

Three Thousand and No/100 -----
DOLLARS (\$ 3,000.00 -----), with interest thereon from date at the rate of five (5%) ----- per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Glassy Mountain Township, in School District 14-D, and being on the East side of Rutherford Road, about 1/2 mile South of Gowansville, and having the following metes and bounds, to-wit:-

"BEGINNING at an iron pin in center of Rutherford Road on line of J. D. Lanford and Reid, and running thence N. 82-54 E. 318 feet to iron pin on Bank of branch; thence up and with said branch on the line of C. H. Campbell, N. 26 W. 215 feet to iron pin; thence N. 74-32 W. 221 feet to iron pin in center of highway; thence with center of highway, S. 40 E. 262 feet to beginning corner."

Said premises being the same conveyed to Gowansville Baptist Church by J. D. Lanford by deed dated January 15, 1946, recorded in Book of Deeds 287 at Page 186.
